THE PROCESS OF GRADUATION APPLYING FOR GRADUATE STUDENT

ABSTRACT

Research on the process of applying for graduation at the Doctoral level aims to improve the graduation application process of Doctoral students, carried out in 3 steps: Step 1. Study the relevant information from the Suan Sunandha Rajabhat University Regulation on Graduate Education; Step 2. Prepare the contents of the manual and step 3. assess the appropriateness of the manual. The tools used are interviews and assessments of the suitability of the manual. Analyze data by analyzing content Averaging and standard deviation. The results showed that the process of applying for graduation at the Doctor of Science level had the results of the assessment of suitability. Overall, it is the most common in all three areas, both in the form of the manual, the content of the manual, and the practical aspect, with an average of 4.75 and a standard deviation of 0.53.




Figure 1: Conceptual framework

RESEARCH METHODOLOGY

2. Research methodology

2.1 Research design

This research is research and development.Research and Development

2.2 Population and samples

The key informants providing significant information were one education officer in graduate school who was responsible for the graduation obtained by purposive sampling. And the person who made the assessment of the suitability of the manual is 7 professors of the Doctor of Philosophy Program in Management Innovation.

2.3 Instrumentation

Research tools include interview forms and process suitability assessments. The tools used for data gathering were the interview form and the suitability assessment form of the manual.

2.4 Testing quality of research instrument

2.4.1 Content validity

By checking the content validity, the researcher took the interview form and the process suitability assessment to the experts. Three people assessed the interview and process suitability assessment and then analyzed the item-objective congruence index (IOC) of 1.00.

2.5 Data Collection

Collect data by interviewing key informants. 1 person and 7 lecturers of Doctor of Philosophy Program in Management Innovation conducted a process suitability assessment.

2.6 Data Analysis

Data were analysed by employing content analysis, mean, and standard deviation.

Three procedures of conducting research included:

3.1 Study relevant information from the announcement. regulations and write a draft of a good practice process

The results of the study of relevant information from Suan Sunandha Rajabhat University Regulation on Graduate Education, announcements, regulations on graduation filing, and writing the process of good practice in graduation filing are as follows:

3.1.1 Suan Sunandha Rajabhat University has issued the Suan Sunandha Rajabhat University Regulation on Graduate Education B.E. 2560 which is a regulation to determine the guidelines and procedures for the submission of graduate students, which was announced on June 28, 2017. In order to complete the graduation, there is a process involved. as follows:

Plan A 2.1

1. Pass the qualification test (Qualifying Examination)

2. Present your thesis and pass the thesis defense exam, which is the final oral exam. The committee appointed by the President must consist of experts from inside and outside the University. The examination must be open to interested parties.

3. The thesis or part of the thesis must be published or accepted for publication in a quality national or international journal according to the Higher Education Commission's announcement on the criteria for considering academic journals for the publication of academic works. Thai-Journal Citation Index Center (TCI) Group 1 and such journals must not be in Beall's List 2 stories

4. Pass the English language proficiency test or pass the English language comparison according to the conditions and criteria specified by the graduate school.

5. Pass the computer literacy exam according to the conditions and criteria specified by the graduate school.

Plan B 2.2

1. Study the various subjects according to the curriculum and terms of the subject.

2. Have a grade point average of not less than 3.00 and an average cumulative hierarchy in a specific subject area of not less than 3.00.

3. Pass the qualification test (Qualifying Examination)

4. Present your thesis and pass the thesis defense exam, which is the final oral exam. The committee appointed by the President must consist of experts from inside and outside the University. The examination must be open to interested parties.

5. The thesis or part of the thesis must be published or accepted for publication in a quality national or international journal according to the Higher Education Commission's

announcement on the criteria for considering academic journals for the publication of academic works. Thai-Journal Citation Index Center (TCI) Group 1 and such journals must not be in Beall's List 2 stories

6. Pass the English language proficiency test or pass the English language comparison according to the conditions and criteria specified by the graduate school.

Duties and responsibilities, process flowchart, graduation filing process, relevant documents in the performance of work. Valid form as (draft) Good Practice Process for Graduating with a Doctorate

3.3 Assessing the suitability of the manual

Evaluation of suitability of (draft) The process of good practice in submitting a Doctor of Philosophy degree from 7 professors of the Doctor of Philosophy Program in Management Innovation as shown in Table 1-4.

As shown in table 4, Assessment of the appropriateness of the good practice process for graduation filing The doctorate in overall utilization was the highest in all 3 items with an average of 4.74 and a standard deviation of 0.51.

CONCLUSION

4. Conclusion

This research was conducted in 3 stages: 1) studying relevant information from Suan Sunandha Rajabhat University Regulations on Graduate Education, announcements, regulations on graduation filings, graduation papers, graduate student handbooks for the academic year 2022, and drafting the process, 2) preparing the content of the process, and 3) evaluating the suitability of the process. The tools used to collect the data are interview forms and assessments of the suitability of the graduation filing best practices process. Ph.D. analyzes data using content analysis. Average and standard deviation Assessment of the appropriateness of the good practice process for graduation filing Overall, the doctorate level was the highest in all 3 areas: booklet, content and utilization, with an average of 4.75 and a standard deviation of 0.53.

5.2. The overall assessment of the suitability of the manual for the thesis proposal examination and the thesis defense examination was at the highest level. When considering separately, each aspect was at the highest level which was consistent with a study on the development of best practice manual for educational quality assurance proceeding by learning exchange conducted by Jinapan and Chaitawittanun (2008) which found that the overall aspects including the contents, language, manual image, and utilization of was appropriate at a high level. Furthermore, the results of Samathi's (2017) study on the development of the manual for dual education between vocational education and secondary education in Sobmoei Wittayakom School, Maehongson province showed that the aspects of correctness, appropriateness, possibility, and utilization, overall, were at the highest level. Similarly, Chaiwut's (2017) study on the development of academic management handbook for the faculty of education, Chiang Mai Rajabhat University found that all three aspects including manual image, contents, and utilization were at a good level.

SUGGESTIONS

6. Suggestions

6.1 The development of the process should be developed in accordance with the Suan Sunandha Rajabhat University Regulations on Graduate Education, Announcement, Regulations on Graduation Submission 2017, Section 8, Graduation.

6.2 Professors of other graduate programs of the College of Innovation and Management should assess the appropriateness of the process of conducting the thesis layout and thesis defense exams in order to receive information and advice on developing processes that are useful and can be used effectively.
